ORDINANCE 2020-O-06

AN ORDINANCE AMENDING THE TRAFFIC SCHEDULE OF THE CITY OF CREEDMOOR

WHEREAS, the City regulates the safety of traffic upon roadways in the city limits pursuant to the authority granted by Article 15 of Chapter 160A of the North Carolina General Statutes and pursuant to Title VII of the City of Creedmoor Code of Ordinances; and

WHEREAS, Section 70.03 of the City Code prohibits truck traffic on all city streets designated in the city's traffic schedule, subject to the exceptions enumerated therein; and

WHEREAS, Sunset Street is a residential city street; and

WHEREAS, that portion of West Lake Road between NC Highway 56 (Wilton Avenue) and US Highway 15 (North Durham Avenue) is a city street; and

WHEREAS, the City has determined that the safety of its citizens and residents is best served by prohibiting truck traffic on Sunset Street and on that portion of West Lake Road between NC Highway 56 (Wilton Avenue) and US Highway 15 (North Durham Avenue), subject to the exceptions enumerated in Section 70.03 of the City Code of Ordinances;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF CREEDMOOR THE FOLLOWING:

- Section 1.** Pursuant to the authority granted by N.C. Gen. Stat. §§ 160A-296 and 160A-300, the Creedmoor Traffic Schedule is hereby amended by adding the following in the appropriate order:
- Prohibit truck traffic on Sunset Street
 - Prohibit truck traffic on West Lake Road between NC Highway 56 (Wilton Avenue) and US Highway 15 (North Durham Avenue)


Section 2. This ordinance shall become effective upon adoption.
