

# MINUTES OF CITY OF CREEDMOOR BOARD OF COMMISSIONERS MEETING AUGUST 11, 2020 5 P.M.

#### **Reconvene Meeting**

At 5:00 p.m. on August 11, 2020, Mayor Wheeler reconvened the recessed meeting from August 3, 2020. Commissioner Ed Mims led the invocation, and Commissioner Kicinski led the Pledge of Allegiance.

Roll call by the City Clerk determined a quorum was present.

# **Cross City Trail Project Update**

City Planner Michael Malecek presented an update on the status of the Cross City Trail project. Malecek highlighted the protection of the wetlands along Robertson Creek, and the cooperation between the city's contractor and the NC DOT contractors constructing the NC Hwy 56 realignment as part of project R-5707. Malecek also highlighted the safety improvements at pedestrian crossings with the installation of concrete islands and flashing beacons to warn motorists of pedestrians in or near the crosswalks. The contract for the completion of Phase II, III, and IV of the Cross City Trail with the Fred Smith Company runs until September 30, 2020.

#### FY21 Budget Amendment #1

Finance Director Reuben Carden presented FY21 Budget Amendment #1, which includes funding to carry forward open purchase orders from FY20, adjust revenues and expenses to account for the cancellation of the 2021 Creedmoor Music Festival, transfer \$2,000 to the 109 Park Ave. Capital Project Ordinance, move a portion of Police Department salaries to the CARES Act special revenue fund, and fund \$22,650 for the Developmental Associates professional services contract for the City Manager search.

Commissioner Nowell moved to approve FY21 Budget Amendment #1. The motion was approved by roll call vote 5-0.

At 5:43 p.m., on August 11, 2020, Mayor Wheeler reconvened the recessed public hearing from August 3, 2020.

City Clerk Terry Hobgood reported that no public comments had been submitted since August 3.

Jake Wolfheil, applicant and South Granville High School Athletic Director, answered questions from the Board of Commissioners regarding his Master Sign Permit application regarding approval from the Granville County Board of Education for the design and placement of the proposed LED sign.

The Board took no action on the draft MSP-2020-01 Ordinance, and Mayor Wheeler directed staff to place this item on the September 1, 2020 meeting agenda for further consideration.

City Attorney Kevin Hornik provided additional information from the City of Creedmoor's adopted Rules of Procedure that states a proposal to substitute completely different wording for a motion shall be treated as a motion to amend, and the amendment is improper if adoption of that amended motion would have the same effect as rejection of the original motion.

The original motion by Commissioner Nowell failed by roll call vote 1-3.

#### Ordinance 2020-O-14 // Amending Chapter 92 Parks and Chapter 93 Streets and Sidewalks

City Planner Michael Malecek presented amendments to Chapters 92 and Chapter 93 of the City of Creedmoor Code of Ordinances to prohibit off-road vehicles from using city sidewalks or the Cross City Trail.

Commissioner Brustmeyer-Brown moved to approve Ordinance 2020-O-14 to amend Chapter 92: Parks and Recreation, subsection 92.01(a) and Chapter 93: Streets and Sidewalks to include subsection 93.01(f) as presented. The motion was approved by roll call vote 5-0.

Finance Director Reuben Carden presented Ordinance 2020-O-15, which establishes a special revenue fund for COVID-19 relief funding as stipulated in the sub-recipient agreement with Granville County.

Commissioner Nowell moved to approve Ordinance 2020-O-15: Establishing a Special Revenue Fund for the Coronavirus Aid, Relief, and Economic Security (CARES) Act. The motion was approved by roll call vote 5-0.

Commissioner Kicinski moved to appoint City Clerk/Public Information Officer Terry Hobgood to serve as the City of Creedmoor representative on the Granville County TDA. The motion was approved by roll call vote 5-0.

**Developmental Associates City Manager Search Contract** 

City Clerk Terry Hobgood fielded questions from the Board of Commissioners related to the proposed not to exceed funding amount recommended by city staff for the Developmental Associates contract.

City Clerk presented the July 7, 2020 Board of Commissioners meeting minutes with a suggested correction by Commissioner Kicinski to change a sentence on page four under SGWASA report to read "commercial/residential" instead of "commercial/industrial."

### **Interim City Manager's Report**

Interim City Manager Mike Turner reported on his transition to the Interim City Manager role, and meetings with outgoing City Manager Korena Weichel and Department Directors. Turner also reported on the completion of LED light installation on E. Wilton Ave. and efforts to recruit a diverse range of applicants for the open city staff positions including Patrol Lieutenant and Recreation Director. Turner then reported on areas of concern that he is addressing with the Cross City Trail, and overgrown vegetation along city streets and sidewalks. Finally, Turner reported on several outstanding items that the city plans to address with the Creedmoor Volunteer Fire Department. Turner reported that he plans to meet with Fire Chief Fisher in the coming days.

# **City Attorney's Report**

City Attorney Kevin Hornik reported on the recent settlement of the City of Creedmoor vs. Johnny Leon Peace, Jr. The settlement allowed the City of Creedmoor acquire a portion of Mr. Peace's property near Lake Rogers Park, and the full details of the settlement are available for public inspection with the Granville County Register of Deeds.

#### **SGWASA Report**

Commissioner Kicinski reported on her recent tours of the water treatment and wastewater treatment plant facilities, and provided an overview of the state of the current SGWASA equipment and technology in the water and wastewater treatment facilities. Kicinski spoke about the need for funding from the state and federal governments to improve SGWASA's infrastructure.

### **Commissioner Reports**

Commissioner Brustmeyer-Brown reported on recent funding that is available for Creedmoor that through the Kerr-Tar Regional Council of Governments. Brustmeyer-Brown also spoke about a personal effort to help alleviate food insecurity through a program called Silent Blessing, which delivers food to those in need. Brustmeyer-Brown also reported on her work with the local Creedmoor Cruisers exercise group to encourage health and wellness in Creedmoor.

Commissioner Kicinski reported that the Granville County Public School system is providing free breakfasts for children in the county, and reported on the upcoming strategic planning session for SGWASA on August 25, which will be open to the public.

Commissioner Ed Mims reported on Commissioner Kicinski's work to modify SGWASA's rate structure, the work of the 109 Park Ave. subcommittee, the upcoming SGWASA strategic planning meeting, and the monthly Creedmoor SGWASA meeting with Executive Director Scott Schroyer. Mims also submitted a proposal to offer the Creedmoor Community Center to the Granville County Board of Elections for the upcoming November election, and asked the Community Development Department to provide information related to the sections of

unincorporated Granville County that are surrounded by the Creedmoor City limits. Finally, Mims spoke about research he has conducted to work with Granville County Public schools to offer internet access to those in need in Creedmoor.

Commissioner Nowell reported on her recent attendance at the July CAMPO meeting and her attendance at the recent UNRBA Path Forward Committee meeting. Nowell has passed on information to the Community Development Department that could allow reimbursement for Creedmoor's efforts to comply with the Falls Lake Rules. Finally, Nowell reported on a recent meeting with the UNC School of Government Local Government Finance Office to participate in a survey on the financial issues facing cities that are using funding for Falls Lake Rules compliance.

Mayor Pro Tem Del Mims reported on a recent advocacy efforts with the Small Cities Council subgroup of the National League of Cities, Women in Municipal Government Board of Directors, and the National League of Cities. Mims also offered remarks about the recent passing of U.S. Senator John Lewis of Georgia. Finally, Mims thanked various city staff members for their recent work on various projects and the transition of City Managers.

# Mayor's Report

Mayor Bobby Wheeler asked that Board members give feedback on the Diversity and Inclusion plan under development by Administrative Services Director Genesis Wallace. Wheeler also spoke about the appointment process for the Parks and Recreation Committee and expressed concern about a sitting committee member not being reappointed even though a seat remains vacant.

Main St. Mims posed a series of questions about the grant approval and award process to City Planner Michael Malecek and City Attorney Kevin Hornik. Malecek reported that the grant program has been suspended, and updates to the Façade Improvement Program guidelines will be presented to the Planning Board at their September meeting and then to the Board of Commissioners upon approval by the Planning Board.
