

MINUTES OF CITY OF CREEDMOOR BOARD OF COMMISSIONERS MEETING AUGUST 26, 2020 5 P.M.

Call to Order

Mayor Wheeler called the meeting to order at 5:00 p.m. Commissioner Brustmeyer-Brown offered the invocation, and Commissioner Kicinski led the Pledge of Allegiance.

Roll Call

Roll call by the City Clerk determined a quorum was present.

Developmental Associates Contract to Conduct the City Manager Search

The Board discussed the draft contract from Developmental Associates with the company's president, Dr. Steve Straus. Dr. Straus provided a summary of the services, and the pricing for his contract proposal plus additional addon costs. Some items in the contract were included in a base fee, and other services would be provided at an hourly rate with no specific price given. Dr. Straus provided additional information regarding the add-on services of providing a City Manager job description and a performance management system for the City of Creedmoor. The Board continued by discussing the process that Developmental Associates would use to recruit a City Manager, and develop other deliverables by the end of the contract term. The Board then discussed various attributes they are seeking in the next City Manager, and discussed some of the key challenges and opportunities facing Creedmoor with Dr. Straus.

Commissioner Kicinski moved to approve the proposed contract with Developmental Associates to conduct the City Manager search process at a cost not to exceed \$19,650. The motion was approved by roll call vote 5-0.

Dr. Straus then presented a timeline for the remainder of the process, which includes writing a job advertisement for review and approval by the Board followed by the recruitment and candidate evaluation period. Dr. Straus stated that there would be several opportunities to screen applicants, and this would involve closed session meetings with the Board to screen and review applications until the final candidate is selected. Dr. Straus estimated that the Board would have the opportunity to interview their top two or three candidates by the end of November 2020.
