ORDINANCE 2020-O-18 AN ORDINANCE AMENDING THE TRAFFIC SCHEDULE OF THE CITY OF CREEDMOOR

WHEREAS, the City regulates the safety of traffic upon roadways in the city limits pursuant to the authority granted by Article 15 of Chapter 160A of the North Carolina General Statutes and pursuant to Title VII of the City of Creedmoor Code of Ordinances; and

WHEREAS, the City regulates the speed limit on City streets as indicated in the City's traffic schedule pursuant to authority granted by N.C. GS § 20-141-e; G.S. § 20-141-f; and

WHEREAS, all streets within the corporate limits of the City of Creedmoor have a speed limit of 25 mph, unless otherwise posted pursuant to Chapter 71.01 of the City of Creedmoor Code of Ordinances; and

WHEREAS, the Davenport subdivision contains city streets known as Fillmore Drive, Irving Place, Marlow Road, Carnegie Court, and Warfield Drive; and

WHEREAS, upon request of the Davenport Home Owners Association, the City has investigated and concurred that that the safety of its citizens, motorists, and pedestrians is best served by lowering the speed limit in the Davenport subdivision on Fillmore Drive, Irving Place, Marlow Road, Carnegie Court, and Warfield Drive from 25 mph to 15 mph.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF CREEDMOOR THE FOLLOWING:

- **Section 1.** Pursuant to the authority granted by N.C. GS § 160A-296 and § 160A-300, the Creedmoor Traffic Schedule is hereby amended by adding the following in the appropriate order:
 - a. Lower the speed limit from 25 mph to 15 mph on Carnegie Court
 - b. Lower the speed limit from 25 mph to 15 mph on Fillmore Drive
 - c. Lower the speed limit from 25 mph to 15 mph on Irving Place
 - d. Lower the speed limit from 25 mph to 15 mph on Marlow Road
 - e. Lower the speed limit from 25 mph to 15 mph on Warfield Drive
- **Section 2.** This ordinance shall become effective upon adoption.
