Ordinance 2021-O-14: Voluntary Annexation of Parcels Owned by TRLC

Mayor Wheeler opened the public Hearing at 6:31 p.m.

Mr. Derek Halberg, 421 Gambit Cr, and Tar River Land Conservancy, Executive Director. Mr. Halberg shared that the Tar River Land Conservancy exists to preserve the natural and cultural resources of the Tar

River Basin and surrounding areas by working in partnership with private landowners, public agencies and others to protect rural landscapes and riparian corridors. The collaborative role that the City played in aiding the TRLC in acquiring the land, which the City contributed 10% towards its acquisition, triggered a further commitment to annex the land into the City of Creedmoor. With this acquisition by the TRLC and the annexation into the City of Creedmoor, the City can continue in its collaborative partnership with the TRLC in exploring future connections to the Cross City Trails on the north, to the Gauntlet on the south, and the existing easements will also allow for the development of at-grade walking paths, bikeways, and greenways along the easements.

Bobby Ray, 205 Church St. inquired as to whether or not the land would be taxable, which it would not due to the nature of the land

City Manager's Report

Manager Smith informed the Mayor and the BOC'rs that the City will continue to monitor the Governor's recommendations as it relates to mask wearing.

CDO Director Frangos reported under the Manager's report that the City was in the final review of the Stewart Comprehensive Plan, and requested of the Mayor and the BOC'rs for recommendations on residents to be appointed to the steering committee.

City Manager Smith also reported that a number of requests have been coming in regarding tenants on the Cell Tower and their desire to either install new equipment at the current lease rate, or to negotiate a reduction of the lease rate payments. After speaking with an industry expert, the CDO Director, the City Attorney and I agree that the City will need to retain an industry expert in aiding our community in developing a telecommunications strategy in order to maintain and/or our revenues. The Board of Commissioners agreed via consensus that the City should protect the City's interest and consult with telecommunications industry experts in order to protect the City's interest.

City Manager Smith also recommend that since new Board members will be coming on board in December, that all efforts to hold the Rules and Responsibilities and DEI workshops be pushed back until after the first of the year, and that efforts are underway to identify availability for both the Board of Commissioners and the workshop facilitators.

City Manager Smith updated the Mayor and the BOC'rs on the ongoing recruitment efforts to fill vacant positions within the City, and that the new City Clerk, James Hicks, will be officially joining the City of Creedmoor on August 10, 2021.

SGWASA Report

Comm'r Kicinski notified the BOC'rs that she will be following up with SGWASA on the MOU for the Modeling project

Commissioners Reports

Comm'r Kicinski shared with the BOC'rs that she and District Representative Russ May have been working together to see if the Veterans Affairs Committee is able to assist Ms. Anne Williams in establishing a veterans small group counseling program in southern Granville County and possibly at the

Creedmoor Community Center. Ms. Williams works independent of the County and the City is awaiting for guidance from the City attorney if she would be able to operate at the CCC without insurance.

Comm'r Brustmeyer-Brown announced the 2021 Kerr-Tar Regional Council of Governments' Annual Awards Banquet to be held Thursday, September 23 and has encouraged the Mayor and Board to attend and to RSVP by the deadline of August 23, 2021. Comm'r Brustmeyer-Brown also informed the Board that there is a need to follow back up with the recent appointees to the DEI Board and get them up and going now that we have a number of members appointed, and they are waiting for direction from the City.

Comm'r Ed Mims reminded the Mayor and Board that we need to continue in our efforts to make sure that the DEI Board is diverse and recognized the caliber of some of the new staff that has been hired to date

Comm'r Del Mims shared with the Mayor and Board that she was able to represent the City at NLC virtual conference from July 8-16.

Mayor's Report

Mayor Wheeler reported that he attended all of the events that he was invited to as well as the 275th Granville Anniversary event that was very well attended.

Commissioner Ed Mims moved to direct the City Manager to issue an RFQ for legal services for the City of Creedmoor and to encourage the Brough Law Firm to submit their qualifications. The motion failed 2-3.
