Discussion Items

Discussion of letter to the editor in BC newspaper by Commissioner Kicinski entitled "Creedmoor citizens must donate to fire department."

Commissioner Ed Mims discussed the letter to the editor. Commissioner Kicinski read an email she received from the editor of the newspaper.

Discussion of access to the building by Commissioner Kicinski per guidance approved by the BOC Commissioner Ed Mims read a statement concerning this agenda item.

Commissioner Ed Mims moved that "in view of the information that Commissioner Kicinski divulged on August 17, 2021 concerning being at City Hall and not attending a public meeting nor meeting with the City Manager as specified in the Board of Commissioners directive, we take historic action and approve a second censure of Commissioner Kicinski for violating the agreed upon directive of the Creedmoor Board of Commissioners that she also approved on March 10, 2021 and for the second time suspend her access to the building."

Commissioner Kicinski read a prepared statement and made a motion to rescind the March 10, 2021 censure and restore her access to City Hall. Mayor Wheeler ruled that the first motion should be dealt with first.

Commissioner Ed Mims restated his motion. Mayor Pro Tem Nowell asked Commissioner Kicinski for the reason she was in the building.

Mayor Wheeler called for the roll call vote on the motion by Commissioner Ed Mims. The motion failed by a roll call vote of 2-3

Commissioner Kicinski moved to "retroactively rescind the illegal out of order motion made by Mayor Pro Tem Nowell on March 10, 2021."

City Attorney Morphis advised that he could provide a legal opinion during closed session if the board would wait to address the motion until after closed session. The board asked him to give the legal opinion during open session.

He reported that the trail boardwalk had been temporarily repaired and trees along the boardwalk were identified that may need work done to ensure that the boardwalk remains safe. Chief King provided research that he had compiled on COVID-19 vaccination incentives and recent complications with finding PPE and tests.

Commissioner Kicinski moved to reinstate the hazard pay for first responders. Commissioner Del Mims moved to amend the motion to include public works employees. The motion was approved by a roll call vote of 5-0.

Good evening, Mr. Mayor, Commissioners, Mr. City Manager, distinguished guests...

My name is Michael W. Magnanti, and in the interest of full disclosure, I am the Vice-Chairman of the Granville County Republican Party.

I come to you tonight to comment on agenda item 10. Discussion items "A" and "B" specifically.

In reference to item 10 a. Discussion of letter to the editor in BC newspaper by Commissioner Kicinski entitled "Creedmoor citizens must donate to fire department." (Commissioner Ed Mims),

I have to believe that the Honorable Commissioner Ed Mims must be unaware that a correction has been issued. ((CORRECTION (8-25-21): The Butner-Creedmoor News included a misleading headline with a previous version of this letter. The letter writer did not say Creedmoor residents must donate to the fire department; she only encouraged residents to do so. The headline has been updated.)

In reference to item 10 b. Discussion of access to the building by Commissioner Kicinski per guidance approved by the BOC. (Commissioner Ed Mims)

I feel this specific issue is so vital that I must speak to you all tonight to express my feelings on it. I have taken the time to listen to the recording of the board meeting that took place on March 10th of this year. I must say that I was surprised at the way you all treated Commissioner Kicinski.

The way you all so easily admonished her even when you all knew that she was alone, with nobody here to help her or defend her.

It's important to me that you all understand how profoundly disappointed I am in the way you treated Commissioner Kicinski.

It is my hope that none of you ever have to face a hostile board with nobody defending you. I can assure you if I have any say, none of you will.

This brings me to what it is that you all actually did, besides berate a defenseless woman until she was broken down and unable to look out for her own best interest, which in not only my view, but also the view of others, was an illegal, out of order motion.

Mayor Pro-Temp, your motion was out of order and illegal. The fact is that nowhere in the city charter or in the General Statute is this board or the city manager granted the authority to limit the access to an elected official.

Nobody on this board is "first among equals" and none of you have the authority to limit access to another elected official. That authority is reserved to the citizens you represent, and when they determine it is time to "limit" your access they will do so through elections.

For that reason, the obvious remedy to this wrong is to rescind this illegal, out of order motion retroactively, and in its entirety including recission of the illegal censure retroactively to March 10, 2021. This will restore Commissioner Kicinski's, and the 1/5 of the citizens of Creedmoor that she represents, full and total access.

It is my hope that this gives all of you the opportunity to consider your actions and reminds you that the citizens of Creedmoor intend to hold you to a higher standard of conduct that includes all of you acting within the scope of your authority. Because if you don't, you can be sure we will point that out.
