#### CALL TO ORDER

# Recommendation on ZTA-2014-02: Mobile Food Vendors

Don Belk presented text amendment recommendations to the Creedmoor Development Ordinance under ZTA-2014-02: *Mobile Food Vendors*. The proposed text amendments include those requirements requested by the Planning Board in their June meeting.
