CONTINUATION OF PUBLIC HEARING: ZTA-2013-01, WIRELESS TELECOMMUNICATIONS FACILITIES

Overview

Assistant Planning, Zoning and Subdivision Administrator Mike Frangos reported on the proposed text amendment regarding telecommunication facilities. Mr. Frangos stated that the consultant hired to assist on the project has produced a standalone ordinance that must be integrated into that of the City. Text is expected to be ready for review by the Planning Board for the regularly scheduled meeting on April 11, 2013.
