## Proclamation

Terminating the Covid-19 State of Emergency within the City of Creedmoor

**Whereas:** on March 10, 2020, North Carolina Governor Roy Cooper declared a State of

Emergency for the State of North Carolina, as defined by N.C. Gen. Stat. 166A-19.3(6) and 166A-19.3(19) based on the public health emergency posed by COVID-

19; and

**Whereas:** on March 23, 2020, A State of Emergency was issued for the City of Creedmoor and

Granville County; and

**Whereas:** on May 22, 2020, Governor Roy Cooper issued Executive Order No. 121, a stay-at-

home order for the State of North Carolina, and allowed North Carolina to enter

Phase II of a three-phased reopening process; and

**Whereas:** on May 22, 2020, a modified State of Emergency was issued for the City of

Creedmoor lifting certain restrictions on the use of picnic shelters and picnic tables

owned by the City of Creedmoor; and

**Whereas:** on September 4, 2020, Governor Cooper issued Executive Order No. 163, moving

North Carolina into the next phase of a three-phased reopening process and relaxing

public health guidelines related to recreational activities and mass gatherings; and

**Whereas:** on September 4, 2020, a modified State of Emergency was issued for the City of

Creedmoor to lift restricted access to playground equipment; and

**Whereas:** on August 15, 2022, effective as of the end of the day, Governor Roy Cooper

rescinded the State of Emergency that was declared by Executive Order No. 116, and all other Executive Orders conditioned upon the State of Emergency declared in

Executive Order 116.

Row, Therefore I, pursuant to the authority vested in me as the Mayor of the City of Creedmoor, under

Article 1-A of Chapter 166-A of the North Carolina General Statutes and Chapter 34.02 of the City of Creedmoor Code of Ordinances, after conferring with my colleagues on the Board of Commissioners, I, Bobby V. Wheeler, Mayor of the City of Creedmoor, North Carolina, do hereby declare and proclaim that for the safety of

our residents:

- 1. To align with the Governor's Termination of the State of Emergency and Executive Orders related to Covid-19 and establish uniformity and consistency with the State pursuant to N.C. General Statute 166A-19.22(c), I hereby terminate the Order issued on March 23, 2020, that declared a State of Emergency within the City of Creedmoor.
- 2. I hereby order this Proclamation: (a) to be distributed to the news media and other organizations calculated to bring its contents to the attention of the general public; (b) to be filed with the Clerk in the City of Creedmoor and (c) to distributed to others as necessary to ensure proper implementation of this Proclamation.
