## RESOLUTION 2024-R-03 [REVISING RESOLUTION 2013-R-13]

- WHEREAS,** pursuant to North Carolina General Statutes 160A, Article 18, the City is authorized to plan and provide for parks and recreation for its residents; and
- WHEREAS,** the City Manager and the Parks and Recreation Director had determined that a committee of City residents should be formed to provide citizen input and recommendations for policies and procedure affecting City recreation; and
- WHEREAS,** the Creedmoor Parks and Recreation Committee (CPRC) was formed as a citizens committee under the guidance of the Parks and Recreation Director on the 12<sup>th</sup> day of August, 2013 [Resolution 2013-R-13]; and

**BE IT RESOLVED THAT** the CPRC shall meet to provide the best possible recommendations concerning recreational policies and procedures, fees, facilities, community programs, long-range planning, grant applications, and the acquisition and disposition of land to the City Manager, the Parks and Recreation Director, and the Board of Commissioners. In addition, it will expand upon departmental goals and objectives by providing a citizen's and community stakeholder's perspective, strive to maintain a high standard for a visually appealing community through the effective management of natural, human and financial resources, and will ultimately work toward developing public interest activities provided by the Creedmoor Parks and Recreation Department, and serve as a liaison between the City and Creedmoor citizens.

### **NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE CITY OF CREEDMOOR THE FOLLOWING:**

**Section 1.** Members of the Creedmoor Parks and Recreation Committee shall consist of eight (8) members to be appointed by the Board of Commissioners pursuant to the organizing by-laws in Attachment A.

**Section 2.** The City of Creedmoor Board of Commissioners (BOC) shall appoint a liaison to maintain mutual understanding and communication between the BOC and CPRC.

**ADOPTED** by vote of the Board of Commissioners of the City of Creedmoor this, the 6<sup>th</sup> day of February, upon motion from Mayor pro tem Kicinski.
